

## ENTRY INFORMATION

Only original works of art completed within the last three years by practicing professional artists living in the Tri-State area are eligible. Work that has previously been shown at the Museum is not eligible. The artist may submit up to 3 works in various media including, but not limited to oil, watercolor, acrylic, pencil, charcoal, pastel, pen & ink, graphic art, collage, sculpture, photography. Work, including frame, should not exceed 40"x40". Eligibility of oversized work and unusual renderings or materials, will be at the discretion of the jury.

Each artist must provide a brief bio of no more than 100 words that will be edited by the Museum for possible use towards the exhibit & PR for this event. The exhibit may be videotaped and or photographed for promotional and or archival purposes. All submitted application materials will become the property of the Staten Island Museum and will not be returned.

## DIGITAL REQUIREMENTS

All artwork may be submitted digitally for the jurying process. This includes two-dimensional, three-dimensional and photography submissions. Submissions will be accepted in the following formats: jpeg or gif. Images no larger than 8x10. Please submit one file for each 2-D work, up to three files for each 3-D work (two of the entire work and one detail), and one file for

each photograph. Entries may be submitted on CD-R. Digital entries will not be returned.

Postmarked deadline is **Friday, May 18, 2012**. Hand delivered entry forms can be submitted until **Saturday, May 19, 2012 by 4pm**.
